## THE RECTOR

HAVING REGARD TO the Guidelines on Visiting Professor and Visiting Researcher (hereinafter referred to as Guidelines) enacted by Rector's Decree n. 3165 of July 6<sup>th</sup> 2023;

HAVING REGARD TO the resolution of January 29<sup>th</sup> 2025, by which the Board of Administration of the University established the maximum amount payable to Visiting Professors;

HAVING REGARD TO the Decree 6159 dated 12.12.2024 of the Director of the Department of Neuroscienze, Riabilitazione, Oftalmologia, Genetica e Scienze Materno-Infantili (DiNOGMI), by which the Department DiNOGMI, upon proposal of Prof. Matteo Pardini, recognized Prof. Siddharthan Chandran, PhD - Full Professor in Neurology, University of Edinburgh as a scholar eligible for the position of Visiting Professor;

HAVING REGARD to the subsequent communication from DiNOGMI, received on 7.01.2025, in which it is specified that, following institutional commitments at the university of origin, Prof. Siddharthan Chandran's activity will be carried out from 16<sup>th</sup> to 27<sup>th</sup> June 2025 instead of 19<sup>th</sup> to 30<sup>th</sup> May 2025;

HAVING REGARD TO the resolution of 29 January 2025 by which the Board of Administration of the University has approved the requests for the co-financing for the II semester of the a.y. 2024/25, according to the previous Guidelines, and among which the co-financing of Prof. Siddharthan Chandran was approved;

HAVING REGARD TO the didactic-scientific plan of the activities approved by the aforementioned Department;

CONSIDERED THAT the Guidelines provides, unlike the previous one, that the reimbursement of travel expenses, food and accommodation is flat-rate;

## DECREES

Art. 1 to appoint Prof. Siddharthan Chandran as Visiting Professor to perform the activities established in the aforementioned didactic-scientific plan from 16<sup>th</sup> to 27<sup>th</sup> June 2025 (total hours 30) in the framework of the Neuroscience PhD School and in the Training Programs in Neurology, Psychiatry, Geriatrics, Nuclear Medicine and Radiodiagnostics focused on neurodegenerative diseases and Alzheimer's Disease;

Art. 2 on the basis of the present decree, a specific agreement with the Visiting Professor will be signed in compliance with art. 5 paragraphs 2,3 of the Guidelines;

Art. 3 the financial resources, including the deductions and charges to be borne by the University and the recipient, will be charged:

- for € 1.469,00 (flat-rate reimbursement) to the University budget for the Visiting Professors, VOCE COAN 4.1.1.1.3.5;

- for € 1.000,00 (recognised contribution by the Department) to the Department's funds;

- for € 2.100,00 (remuneration) to the Department's funds.
