Decree no. 4685

THE RECTOR

Having regard to Law no. 240 of 30.12.2010 and subsequent amendments and additions containing rules on the organisation of universities, academic staff and recruitment, as well as delegation to the Government to promote the quality and efficiency of the university system, and in particular art. 22, containing provisions on research grants;

Having regard to the D.R. no. 2002 of 23/5/2019 by which the Regulation for the assignment of research grants was last amended;

Having regard to the resolution of the Board of Directors of 22.7.2015 by which the amounts of the research grants and the calendar of procedures were determined, pursuant to art. 1 of the abovementioned "Rules for the granting of research grants";

Given the DD. RR. n . 4334 of 27.10.2020 and 4491 of 5.11.2020 with which n. 48 public selections for the awarding of n. 49 research grants, published in Alboweb on 27.10.2020;

Considering that the procedures of programmes n. **6-10-11-13-17-20-25-31-32-33-35-37-38-39-40** indicated in Annex A, integral part of the above mentioned call n. 4334 of 27.10.2020, provide for tests with attendance procedures;

Considering that, following the issue of the Prime Ministerial Decree 3.11.2020 concerning the emergency related to the COVID epidemic, it is necessary to proceed with the rectification of the notice referred to in D.R. 4334 of 27.10.2020 by providing that the above mentioned procedures indicated in Annex A be carried out remotely;

Considering that it has been ascertained that the scientific managers of the above-mentioned procedures are available to carry out in telematic mode,
