Title: Chemical and textural fingerprint of natural **stones** for the use of construction and restoration stakeholders (Cat Stone).

Description: The project intends to associate the DTA-TG GC / MS bulk investigation technique and the microtextural analysis on images obtained by scanning electron microscopy (SEM). The activity of the research fellow, developed over a year, includes:

Definition of the objectives: Definition of the dataset, retrieval of 50 ornamental lithotypes. The analytical campaign foresees to conduct in parallel the microtextural and compositional analysis with SEM EDS and the TG DTA analysis of ornamental lithotypes. Data processing includes the elaboration of about 100 thermograms and the joint gas chromatographic analysis, the elaboration of microtextural analyses by digital image analysis of 100 ornamental lithotypes to be included in the EIP NATUREUROSTONE dataset. Finally, the publication and dissemination activity involves participation in conferences, publication in ISI journals, a social outreach event.
