Title: Contribution to the edition of Metastasio's correspondence: new research and commentary on texts within the new digital edition of the M.E.T.A. project.

Description: The M.E.T.A. project ("Metastasio's Epistolary Texts Archive") promoted by DIRAAS has almost completed its first phase; the digital platform is practically operational. Significant problems remain about the modalities of commenting on the letters, above all in relation to the technical possibilities of the interrogation of the texts. The "assegnista" (Reserch Fellow) - in close contact with the scientific committee of M.E.T.A. - will have to deal with these aspects and make the implementable form operative. The "assegnista" will also have the task of commenting and uploading on the platform some important works by Metastasio, to be agreed with the scientific committee.

Title: The language and discourse of Spanish and Italian Trade Unions in the second half of the 20th century.

Description: The project investigates the language and discourse of Spanish and Italian Trade Unions in the second half of the 20th century. Corpora compiled on the basis of archival funds on labour and trade union organizations in Italy and in Spain will be analyzed and a database will be created in order to carry out comparative research on the lexicon, terminology and translations of these texts, as well as their variability over time. A qualitative and quantitative approach will be combined, relying on the Corpus-Assisted Discourse Studies (CADS) methodology. In addition to the database, a Spanish-Italian glossary on Trade Union terminology will also be created.

Title: Crossing the differences: Gandhi's religion between ethical-philosophical universalism and historical faiths.

Description: Gandhi is universally renowned as a social reformer, leader of the Indian national movement and a theorist of nonviolence. Less well known is that he elaborated an original hermeneutic rereading of the world religions. The project focuses on the analysis of this important aspect, whose relevance is attested by the peculiar spiritual situation of our time, which proposes a division into often closed and intolerant forms of identity. The aim of the research is to produce a monograph that illustrates Gandhi's interpretive horizon, in its theoretical and practical attempt to hold universal and particular in dialectical tension, on the one side recognizing the irreducibility of the faiths, on the other side finding a third-party principle capable of acting as a relational bridge among them.

Title: Authority: Problems, Concepts, and Contemporary Models.

Description: The problem of authority is central for legal philosophy. Three fundamental questions must be considered: What is ‘authority’? Ought ‘authority’ to be obeyed? Is there any relation between these two questions?

From the perspective of analytical legal philosophy, the project pursues a threefold aim. First, offering some clarification about the contemporary debate on “authority”, as it is sometimes unclear what the disagreement (if any) is about. Second, showing that there are some common patterns in approaching “authority”, which can be represented as general “discourse models”, and thus analysed and compared. Third, inquiring upon what the most adequate “discourse model” to approach “authority” is, provided we adopt a neutral, description-gearred, and less-assumption-dependent philosophical approach.

Title: Family support policies at local level: economic analysis of costs and benefits of services provided.

Description: The Municipality provides individual demand services and guarantees economic benefits to those in need. There are several criteria proposed to select the recipients of the benefits but the "means test" currently most used is the ISEE. However, there is a widespread belief that ISEE is not always the most appropriate tool. The local public administrator has the necessity and the duty to support the community according to the "effective need", guaranteeing an equitable and efficient allocation of available resources, consistent with the budget constraints.

The aim of the research is to develop a decision-making support for the Municipality by offering suitable information tools for fair and sustainable social policies, through the economic-quantitative analysis of the data of: public accounting; fiscal declaration; databases (ISTAT; Bank of Italy; Municipality; Region).

Title: The political thought of H. Belloc: Catholicism and politics in early XX Century England.

Description: The research project is focused on the analysis of the political thought of Hilaire Belloc, author of many works such as *The servile State*, *The House of Commons*, etc. The project aims to work in depth on the British context with a special attention to show the peculiarities of Belloc's position and to underline the importance of its link with the social doctrine of the Catholic Church. A special attention will be also devoted to the intellectual and political sources of Belloc's vision. The project wants to widen its range of analysis including political theorists and philosophers coming from the Italian context, which is regarded as significant with reference to the developments of Catholicism and its political proposals. The project is destined to be necessarily developed within an international milieu, implying cooperations and exchanges with scholars coming from the British academic world.

Title: After us. The effects of precariousness on the choice of separation of young families.

Description: The project aims at exploring how the intersection among age, gender and precariousness affects the plan-making attitude of young families which face separation. With particular attention for cases of separation caused by gender-based violence, the research analyses the effects of policies and laws on the processes of separation, within the broader frame of the “Welfare crisis”, whereby the instable relation with structures like the labour market, the family and the educational system makes the individual and couples’ choices more complex. By integrating biographical and gender perspectives, the qualitative approach of the project puts into relation the life course research with policy analysis, aiming to understand how the “revision” of life choices is (re)shaped by the negotiation between subjects and opportunity structures.
