THE RECTOR

Having regard to the D.R. **no. 2837 dated 16.6.2023** with which 20 public selections have been made for the awarding of no. 20 research fellowships in the programmes specified in Annex A, integral part of the aforesaid announcement, in particular the procedure under **programme no. 20** for the awarding of a research fellowship - duration 1 year, gross annual amount: \notin 19,367.00 - entitled "Impact assessment of robotics and artificial intelligence projects within the RAISE Ecosystem" with reference to the Funding: PNRR - Ecosystem of Innovation ECS000035 "RAISE (Robotics and AI for Socio-economic Empowerment)" - Spoke 5 D.D. no. 1053 of 23.06.2022 (CUP D33C22000970006);

Having regard to the following D.R. **no. 3009 dated 26.6.2023** with which 24 public selections have been made for the awarding of no. 25 research fellowships in the programmes specified in Annex A, integral part of the aforesaid announcement;

Considering that, due to a mere clerical error, **programme no. 23** entitled "Impact assessment of robotics and artificial intelligence projects within the RAISE Ecosystem", containing the activation of a research grant already announced by **D.R. no. 2387 dated 16.6.2023** (**programme no. 20**), was erroneously included in the aforementioned call for applications under **D.R. no. 3009 dated 26.6.2023**;

Considered, therefore, that the correct request for activation of the research fellowship entitled "Impact assessment of robotics and artificial intelligence projects within the RAISE Ecosystem" must refer only to that referred to in programme no. 20 of the call issued by D.R. no. 2837 dated 16.6.2023, and that programme no. 23, having the same title, must not therefore be included in the call issued by D.R. no. 3009 dated 26.6.2023;

HEREBY DECREES

- 1. For the reasons set forth above, the notice issued by **D.R. no. 3009 of 26.6.2023** shall be deemed to have been partially amended as follows: the procedures called shall be deemed to be n. 23 (not 24), with the cancellation in Annex A, an integral part of the notice, of programme no. 23.
- 2. Applications submitted by candidates to participate in the selection under programme no. 23 of D.R. no. 3009 dated 26.6.2023 shall be deemed valid as if submitted for programme no. 20 of D.R. no. dated 16.6.2023.
